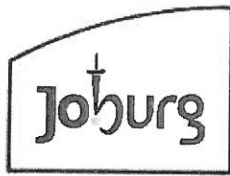

  - 4.4. Central Supply Database (CSD) Registration Report, indicating tax information as compliant, director not a government employee and not included in the Restricted Supplier database
  - 4.5. Completion of the following MDB forms among others,
    - 4.5.1. MBD 4 : Declaration of Interest,
    - 4.5.2. MBD 6.2 : Local Content (If applicable)
    - 4.5.3. MBD 8 : Declaration of bidder's past Supply Chain Management Practices

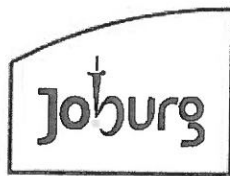




