- · Cutting, collecting and removal of grass, shrubs and other vegetation within the boundary fence and up to a maximum of 1 meter around the applicable area in the absence of a boundary fence. The collected grass and shrubbery must be dumped on waste designated areas.
- \cdot Grass, shrubs and other vegetation shall be cut 1 meters outside the fence perimeter as and where agreed upon.
- · Kill the weeds, grass, shrubs or any vegetation by means of chemical on areas where it is impossible to use equipment and trim edges neatly using trimmers and or bush cutters (e.g. around poles and on the edges of buildings and pavements).
- · Length of the cut grass to be between 20 to 50mm as measured from soil.
- · Contractors should also clear grounds within the boundary fence of all litter, obsolete parts, excessive work material and other debris
- · The contractor shall be responsible to sweep the paving and roads and to remove all grass, shrubs and vegetation off-cuts generated on specified grass cutting area within two working days after the grass cutting operations has taken place including the legal disposal thereof at an authorized waste disposal site at his/her own cost.
