## **SCOPE OF WORK (JPC MBD 10)**

#### **PURPOSE**

The purpose of cleaning on a daily basis during night shift is to prevent the spread of infections and disease, control, as well as to have hygienic cleaned public ablutions. During night shift there will be no foot traffic interrupting the cleaning services. JPC is determined to have a cleaned acceptable environment and for safety reasons; as hygiene cannot be compromised at all times.

#### **BACKGROUND**

On 28 April 2020, the Department of Employment and Labour issued guidelines for employers to deal with COVID-19 at workplaces. The Department of Employment and Labour appealed to employers to use the prescriptions of the OHSA, in particular, the Hazardous Biological Agents Regulations governing workplaces in relation to Coronavirus Disease 2019 caused by the SARS-CoV-2 virus.

In addition to direct human-to-human transmission, contaminated surfaces also pose a risk of transmitting viruses and pathogens. Especially in the current COVID-19 pandemic, this is of great importance: Studies show that SARS-CoV-2 viruses can survive for several days on surfaces that we come into daily contact with as indicated above.

All work surfaces and equipment are disinfected before work begins, regularly during the working period and after work ends; all areas such as toilets, common areas, door handles, and shared electronic equipment are regularly cleaned and disinfected. Measures to keep your surfaces tidy include deep cleaning, sanitising, disinfecting and fogging.

The country is currently on lockdown and suppliers will be requested to provide the cleaning services for night shift at the taxi ranks and informal markets to keep the facilities hygienic at all times. JPC manages public transport facilities within the City of Johannesburg on behalf of the City.

Suppliers will rotate every 14 days per batch; there are 15 Facilities in Region F.



- 1. Ward Councillors list of people to be employed
- 2. Gender will be considered % as indicated by Councillors. At least 50% women and 50% male cleaning staff to be considered for appointment.
- 3. Rotation till end July thereafter find a more sustainable manner for ongoing maintenance cleaning.
- 4. Contractors expected to bid for the jobs coming from the Ward.
- 5. All expenses to be covered by the contractor.
- 6. Liaison with Taxi associations and Hawker Committees.
- 7. Materials supplied by our Contractors directly.
- 8. Contractor must at least be registered with CIPC.
- 9. Attachment of SMME with bigger established businesses for training.
- 10. Preference given to ward based entities then within the region.

### Methodology

- 1. Each contractor to be appointed for a maximum of 14 days.
- 2. Each contractor to be allocated a cleaners from the list provided by the Ward Councillor also for 14 days.
- 3. At the end of 14 days the contract ends both Contractor and Employee.
- 4. Worker to keep the allocated PPE after contract ends.
- 5. A new contractor will be appointed for the next 14 days.
- 6. No permanent appointments for contractor or Labour.

## Scope of work

- 1. Clean toilet facilities, pavements, basement and stalls sweep, disinfect.
- 2. Clean offices, vacuum floors, dust, clean door knobs
- 3. Clean surfaces and wiped down with disinfectant.



- 4. Clean hand rails, sanitise.
- 5. Sweep, mop toilets / wet mop hard surface flooring.
- 6. Remove waste, papers, trash from receptacles and move to designated area.
- 7. Clean windows in the bathrooms and wipe glass doors for offices and wipe frames.
- 8. Clean standing or hanging directory or signage's.
- 9. Dust HVAC ventilation grills if any.
- 10. Spot clean walls, light switches etc.
- 11. Replenish toilet papers, hand soap.
- 12. Clean mirrors, hand basins and countertops.
- 13. Clean and sanitize stall partitions, shelves, fixtures and dispensers.
- 14. Clean and sanitize all toilets, urinals and adjacent wall surfaces.

## **Management and Supervision**

- 1. The supplier to provide supervision to ensure compliance with specifications.
- 2. The supplier to provide supervision to ensure employees are trained, safety and security measures to be put in place.
- 3. The supplier to report any problems or safety hazards to JPC immediately.

## Supplier's responsibility

- To ensure that all cleaning staff members have proper full PPE to minimise their exposure and risk on infections. As announced by the President of SA on the 23 April 2020, all staff must wear cloth masks and hand cloves at all times.
- 2. All cleaning staff must wear reflector jackets for visibility at all times, since they will be working night shift.
- 3. It is the responsibility of the supplier to provide transport to the cleaning staff and also to ensure safety of the cleaning staff at all times. JPC will not be held responsible or liable for any incidents or safety of the supplier's cleaners.





- 4. The Supplier must ensure that all cleaning staff signs off a daily attendance register when reporting for duty.
- 5. Should any cleaning staff be ill or be infected during the period, it is the duty of the supply to notify JPC immediately.
- 6. The supplier must ensure that the cleaning staff are checked for body temperatures on a daily basis with a thermometer to ensure that the staff are fit for duty.
- 7. The supplier must ensure that there is adequate cleaning materials at all times at the facilities.
- 8. The supplier must ensure that the cleaners adhered to the regulations and keep 1.5 meters of social distancing at all times.
- 9. The supplier must provide hand sanitisers and ensure that the cleaning staff adhered to this and practice hand hygiene.

- Appointment in Force and Authorised Signatories: This appointment is considered to have come into force immediately after all the necessary signatures have been appended.
- 2. Independent Contractor: The Service Provider is appointed as an independent contractor and no contract of agency and/or employment is created. Save as may be expressly authorised by JPC from time to time in writing, the Service Provider shall not hold itself out to be the agent of JPC and/or commit JPC to any contract or obligation of whatever nature.
- **3. Alterations**: Should circumstances arise which call for modifications of the appointment, these may be made by mutual consent given in writing. Proposals in this respect from one party shall be given due consideration by the other party.
