SCOPE OF WORK

 - o Identify the root causes that led to the IFW expenditure transgressions
 - Recommendation improvement in the control environment to limit or avoid repeat occurrence
 - Identify any breakdown in the designed internal controls and recommend remedial intervention.
 - o Identify individuals and their roles in the IFW expenditure
 - Recommend write off or assess the possibility of recover of the expenditure, whether in full or a reasonable percentage
 - Determines that there is prima facie evidence that the expenditure was incurred deliberately or negligently but requires further investigation.
 - Present the investigation report to the board.
 - o Each incident of IFW requires its own investigation and report
 - Each report to cover the following sections:
 - The reason why the expenditure was categorised as irregular
 - The context for the expenditure;
 - The cost of the expenditure, including a breakdown by cost and quantity of the goods or services received;
 - A determination whether the JPC lost any money by awarding the contract to the respective service provider;
 - A determination if the JPC can recover money from the service provider, official or political office-bearer;
 - A determination of whether the irregular expenditure was a minor breach or of a purely technical nature;
 - A determination whether the expenditure was incurred deliberately or due to gross negligence;
 - A list of every expenditure incurred by the official or political office-bearer, according to the UIFW register of the JPC;
 - A determination whether the actions of the official or political office-bearer should be referred to the Accounting Officer and Disciplinary Board;
 - A list of every contract identified as expenditure that the service provider received;
 - A determination whether there were any conflicts of interest in the awarding of the contract that resulted in the expenditure;
 - Recommendations on the recovery of the expenditure;
 - Remedial action to be implemented;
 - A summary account of the investigation; and all relevant annexures.

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1. This municipal bidding document (MBD) must form part of all bids¹ invited.
- 2. Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).²
 Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
