- 1) Strip the old rusted and rotten box gutter
- 2) Supply and install the new gutter resembling the old one (treated gutter)
- 3) Make sure there are no leakages on the joins and down pipes
- 4) Replace damaged ceiling boards
- 5) Supply paint to paint the workshop
- 6) Should carry a guarantee of at least 12 months

CERTIFICATE OF INDEPENDENT BID DETERMINATION

1. This municipal bidding document (MBD) must form part of all bids¹ invited.
2. Section 4(1)(b)(iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a per se prohibition meaning that it cannot be justified under any grounds.
3. Municipal Supply Regulation 38(1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
