#### SCOPE OF WORK

**1.)** All build in air-con heaters in Health Finance offices needs to be serviced and repaired at Health Finance offices 4th floor B Block, so that they are in a working order;

2.) The Door latches in main offices of bookkeepers and procurement officers and Director: Finance also needs replacing. All door latches and handles needs to be checked as they are wearing out.
3.) A set of spare key's needs to be cut for main offices of bookkeepers and procurement officers including the Deputy Director: Finance, Mr. Frans Moseane and Assistant Director: Mr. Mashao Rakgole

4.) The two Men's Toilet taps and toilet seats are not functioning just before you approach the MMC's office and District Health Service Development Unit respectively;

5.) The one ladies toilets (cubicle) on 4th floor B Block, has been non-functional for a long time as you approach the MMC's office. The seats on the other's needs also to be attended to as they are falling apart.

6.) In general, all toilets on the 4th floor B Block needs to attended to with various repairs and maintenance, as the upkeep is not good.

7.) Window of the Operational Manager's office is broken and needs replacement;

8.) Plastic screens (as those used at Bank tellers) are needed to protect all bookkeepers/ asset officers and procurement officers in the main area;

9.) The Director: Finance office two cupboards also requires repairs as it is not functioning. The bookkeepers two cupboard also needs to be repaired.

10.) The carpets at 4th floor B Block also needs to be cleaned, as they are dirty or replaced, as they are quite old.

11.) The lights at 4th floor B Block (Health Finance Section) have an electrical fault (lights and plugs) as it is dark at many offices.

# DECLARATION CERTIFICATE FOR LOCAL PRODUCTION AND CONTENT

This Municipal Bidding Document (MBD) must form part of all bids invited. It contains general information and serves as a declaration form for local content (local production and local content are used interchangeably).

Before completing this declaration, bidders must study the General Conditions, Definitions, Directives applicable in respect of Local Content as prescribed in the Preferential Procurement Regulations, 2011 and the South African Bureau of Standards (SABS) approved technical specification number SATS 1286:201x.

#### 1. General Conditions

- 1.1. Preferential Procurement Regulations, 2011 (Regulation 9. (1) and 9. (3) make provision for the promotion of local production and content.
- 1.2. Regulation 9. (1) prescribes that in the case of designated sectors, wherein the award of bids local production and content is of critical importance, such bids must be advertised with the specific bidding condition that only locally produced goods, services or works or locally manufactured goods, with a stipulated minimum threshold for local production and content will be considered.
- 1.3. Regulation 9. (3) prescribes that where there is no designated sector, a specific bidding condition may be included, that only locally produced services, works or goods or locally manufactured goods with a stipulated minimum threshold for local production and content, will be considered.
- 1.4. Where necessary, for bids referred to in paragraphs 1.2 and 1.3 above, a two-stage bidding process may be followed, where the first stage involves a minimum threshold for local production and content and the second stage price and B-BBEE.
- 1.5. A person awarded a contract in relation to a designated sector, may not subcontract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 1.6. The local content (LC) as a percentage of the bid price must be calculated in accordance with the SABS approved technical specification number SATS 1286: 201x as follows:

  - this declaration certificate is not submitted as part of the bid documentation.
  - 2. Definitions
    - 2.1. "bid" includes advertised competitive bids, written price quotations or proposals:
    - 2.2. "bid price" price offered by the bidder, excluding value added tax (VAT).
    - 2.3. "contract" means the agreement that results from the acceptance of a bid by an organ of state;
    - 2.4. "designated sector" means a sector, sub-sector or industry that has been designated by the Department of Trade and Industry in line with national development and industrial policies for local production, where only locally produced services, works or goods or locally manufactured goods meet the stipulated minimum threshold for local production and content;
    - 2.5. "duly sign" means a Declaration Certificate for Local Content that has been signed by the Chief Financial Officer or other legally responsible person nominated in writing by the Chief Executive, or senior member / person with management responsibility(close corporation, partnership or individual).
    - 2.6. "imported content" means that portion of the bid price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or its subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs, such as landing costs, dock duties, import duty, sales duty or other similar tax or duty at the South African port of entry;
    - 2.7. "local content" means that portion of the bid price which is not included in the imported content, provided that local manufacture does take place;

# CERTIFICATE OF INDEPENDENT BID DETERMINATION
