### **The services and/or goods required are:**

The appointment of a suitably qualified and competent structural engineer to comprehensively assess the Usindiso building, and ascertain if the building is still structurally sound to be retrofitted in order to make to habitable and also if the existing foundations can carry additional load (additional 4 floors over and above the existing 4 floors) or if the buildings should be demolished to make way for a new structure.

The scope should only be limited to structural assessment and should exclude designs, mechanical , wet services and electrical assessment.

The bidder should assume that minimum required Non Destructive Tests (NDTs) will be required. As such the quote should include coming up with Terms of reference(TORs) for the NDT service providers, monitoring them, evaluating the outcome of the NDTs and incorporating same into the structural integrity report.

## **CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)**

This section sets out how personal information will be collected, used and protected by the City of Joburg Property Company SOC Ltd (hereinafter referred to as “JPC”), as required by the Protection of Personal Information Act.
