SCOPE OF WORK (JPC MBD 10)

Background

The City of Joburg Property Company (JPC) SOC Ltd regularly requires the services of contractors for the delivery of services related to the development and management of the COJ's land portfolio and in the effective operation of its own core business.

A Panel of Contractors was established by JPC in May 2022 and JPC has been sourcing required repairs and maintenance services from this panel. The Panel was established for a period of 3 years and is due to expire in May 2025.

A new Panel needs to be established for the next three-year period to replace the existing panel.

The objective is to have a readily available pool of contractors, which can be invited to submit pricing proposals for the Plumbing class of works from time to time once prequalified to be on the panel.

Plumbing (SO) is one of the Classes of Works/ Category that encompass diverse fields of expertise, specialization and competence in the Construction Industry Development Board (CIDB)

Plumbing services refers to the development, extension, installation, renewal, removal, alteration, or dismantling or demolition of water installations and soil and wastewater drainage associated with buildings (wet services and plumbing).

The Basic Work Type examples for Plumbing services (SO) include but are not limited to:

- Water supply;
- Rain water disposal;
- Piping to swimming pools;
- Sub-soil drainage;
- Soil drainage;
- Sanitary plumbing;
- Electrical water heaters (Electrical and Solar geysers);
- Waste water;
- Septic tanks;
- Pre-paid water meters;
- Portable toilets;
- Irrigation;
- Water tanks
- JPC is targeting a maximum of 25 (Twenty-Five) bidders to be included in the Panel of Plumbing under CIDB 2SO as and when required, based on the functionality. The top 25 highest scoring bidders will be included on the Panel of Plumbing (2SO) as and when required. If there are more than 25 bidders that scored 70 and above, the preferential JPC SCM process will be undertaken
- JPC is targeting a maximum of 25 (Twenty-Five) bidders to be included in the Panel of Plumbing under CIDB 3SO as and when required, based on the functionality. The top 25 highest scoring bidders will be included on the Panel of Plumbing (3SO) as and when required. If there are more



than 25 bidders that scored 70 and above, the preferential JPC SCM process will be undertaken

- JPC is targeting a maximum of 15 (Fifteen) bidders to be included in the Panel of Plumbing under CIDB 4SO as and when required, based on the functionality. The top 15 highest scoring bidders will be included on the Panel of Plumbing (4SO) as and when required. If there are more than 15 bidders that scored 70 and above, the preferential JPC SCM process will be undertaken
- JPC is targeting a maximum of 15 (Fifteen) bidders to be included in the Panel of Plumbing under CIDB 5SO as and when required, based on the functionality. The top 15 highest scoring bidders will be included on the Panel of Plumbing (5SO) as and when required. If there are more than 15 bidders that scored 70 and above, the preferential JPC SCM process will be undertaken

1. Operation of the Panel

2.1 Allocation for Emergency Works

The successful bidders in grades **2SO & 3SO** will be allocated work for emergency works on a rotational basis. There will be no need for quotations as the rates have been pre-determined based on a schedule of rates (**Bill of Quantities**). The only time quotations will be solicited from the contractors will be for items that are not in the approved schedule of rates. The Schedule of Rates will be fixed for the first contract year and will be reviewed and adjusted on an annual basis based on contract price adjustment provisions as published by statistics South Africa.

Emergency repairs are repairs that are carried out to remedy any defect which puts the health, safety or security of people or third party at immediate risk or which affects the structure of building.

The process followed in allocating work is different from that of planned projects, necessitates distinction. Service providers may be required to provide emergency work that may be specialised in Plumbing and the next service provider in line as per the rotation plan might not necessarily have the specialised skills to complete the work. This would necessitate that such service providers be skipped, and such emergency work being allocated to the next capable service provider on the rotation list.

Contractors might fail to attend to calls made for work that they regard as "small jobs", such as replacement of taps, washers etc. The required work will be allocated to service provider next in line in the rotation list in such a case.

The affected department must ensure that sufficient evidence is submitted to show that work was allocated to a certain service provider and that the service provider rejected the allocation.

2.3 ALLOCATION OF WORK FOR PLANNED MAINTENANCE

- The appointment into the JPC's Contractors does not guarantee that the panellist will receive actual appointment for the project that are being implemented. JPC to run a competitive process within the established panel;
- b. Services will be sourced on an as and when required basis from the panel of Contractors and in terms of JPC SCM Policy and guidelines;
- c. Requests for quotations will be advertised on the JPC notice boards and website. The notices will remain on the JPC notice boards and website for seven days;



- d. It is the responsibility of the Contractor to ensure that they check the JPC notice boards and website regularly and respond to JPC's requests for quotations as set out herein;
- e. It is important to note that no officials from JPC will contact any Contractor for the purpose of obtaining quotes outside of the above process.

NB: Maximum bidders for Grade 4SO and 5SO will be 15 Bidders per Grade allocated onto the panel from highest scoring downwards.

The maximum threshold for any appointment through the panel will not exceed **R5 million** including VAT. Where the value of work exceeds **R5 million** including VAT, such procurement will be subjected to a competitive tender process outside of the panel.



- 1. Appointment in Force and Authorised Signatories: This appointment is considered to have come into force immediately after all the necessary signatures have been appended.
- 2. *Independent Contractor:* The Service Provider is appointed as an independent contractor and no contract of agency and/or employment is created. Save as may be expressly authorised by JPC from time to time in writing, the Service Provider shall not hold itself out to be the agent of JPC and/or commit JPC to any contract or obligation of whatever nature.
- **Alterations**: Should circumstances arise which call for modifications of the appointment, these may be made by mutual consent given in writing. Proposals in this respect from one party shall be given due consideration by the other party.
- **4. Assignment:** The Service Provider shall not without the prior written consent of JPC, cede or assign any of the benefits and obligations under this appointment.
- **Sub-Contracts:** Any sub-contracts or modifications or termination thereof relating to the performance of the services by the Service Provider shall be made only with the prior written consent of JPC.

CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI) JPC MBD 23

This section sets out how personal information will be collected, used and protected by the City of Joburg Property Company SOC Ltd (hereinafter referred to as "JPC"), as required by the Protection of Personal Information Act.

The use of the words "the individual" for the purposes of this document shall be a reference to any person, with reference to the bidder and its directors/shareholders/personnel, communicating with JPC and/or concluding any agreement, registration or application, with the inclusion of each of those individuals referred to or included in terms of such agreement, registration or application.

1. What is personal information?

The personal information that JPC may require relates to names and surnames, birth dates, identity numbers, passport numbers, demographic information, education information, occupation information, health information, addresses, memberships, and personal and work email and contact details.

2. What is the purpose of the collection, use and disclosure (the processing) of personal information?

JPC is legally obligated to collect, use and disclose personal information for the purposes of:

- reporting initiatives to the City of Johannesburg Metropolitan Municipality;
- reporting all contracts awarded to National Treasury;
- obtaining information related to Tax Compliance information from SARS;
- verifying information on the National Treasury database of defaulters;
- evaluating and processing applications for registration on the database;
- compiling statistics and other reports;
- providing personalised communication in respect of the tender/quotation submitted;
- complying with the law; and/or
- for a purpose that is ancillary to the above.
- for the evaluation and adjudication of Quotations, Request for Proposals and Panel of service providers
- posting all awards for Request for Proposals and Panel on the JPC website

Personal information will not be processed for a purpose other than what is identified (the purpose) above without obtaining consent beforehand.



3. How will JPC process personal information?

JPC will only collect personal information for the purpose as stated above. Information will be collected in the following manner:

- directly from the individual
- through the documents submitted with the tender/quotation;
- from service providers who provided services or goods to JPC;
- from JPC's own records relating to previous supply of services or goods; and/or
- from a relevant public or equivalent entity.

4. To whom will personal information be disclosed?

The personal information may be disclosed to other relevant public or other entities on whose behalf we act as intermediaries, other third parties referred to above in relation to the purpose or who are sources of personal information, service providers such as professional bodies who operate across the borders of this country (transborder flow of information), where personal information must be sent in order to provide the information and/or services and/or benefits requested or applied for.

In the event of another party/ies acquiring all of or a portion of JPC's mandate or functions, personal information will be disclosed to that party but they will equally be obliged as we are, to protect personal information in terms of this policy and the law.

In respect of Request for Proposals and Panel to the Bid Evaluation and Adjudication Committee members

5. Consent and Permission to process personal information:

I hereby agree with the policy and provide authorisation to JPC to process the personal information provided for the purpose stated:

- I understand that withholding of or failure to disclose personal information will result in JPC being unable to perform its functions and/or any services or benefits I may require from JPC.
- Where I shared personal information of individuals other than myself with JPC I hereby provide consent on their behalf to the collection, use and disclosure of their personal information in terms of this personal information policy and I warrant that I am authorised to give this consent on their behalf.
- To this end, I indemnify and hold JPC not responsible and harmless in respect of any claims by any other person on whose behalf I have consented, against JPC should they claim that I was not so authorised.
- I understand that in terms of POPIA and other laws of the country, there are instances where
 my express consent is not necessary in order to permit the processing of personal information,
 which may be related to police investigations, litigation or when personal information is publicly
 available.



• I will not hold JPC responsible for any improper or unauthorised use of personal information that is beyond its reasonable control.

6. Rights regarding the processing of personal information:

- The individual may withdraw consent to the processing of personal information at any time, and should they wish to do so, must provide JPC with reasonable notice to this effect. Please note that withdrawal of consent is still subject to the terms and conditions of any contract that is in place. Should the withdrawal of consent result in the interference of legal obligations, then such withdrawal will only be effective if JPC agrees to same in writing. JPC specifically draws to the attention that the withdrawal of consent may result in it being unable to provide the requested information and/or services and/or financial or other benefits.
- In order to withdraw consent, please contact the JPC Information Officer/SCM
- Individuals are encouraged to ensure that where personal information has changed in any respect to notify JPC so that our records may be updated. JPC will largely rely on the individual to ensure that personal information is correct and accurate.
- The individual has the right to access their personal information that JPC may have in its
 possession and are entitled to request the identity of which third parties have received and/or
 processed personal information for the purpose. Please note however, that any request in this
 regard may be declined if:
 - the information comes under legal privilege in the course of litigation,
 - the disclosure of personal information in the form that it is processed may result in the disclosure of confidential or proprietary information,
 - giving access may cause a third party to refuse to provide similar information to JPC,
 - the information was collected in furtherance of an investigation or legal dispute, instituted or being contemplated,
 - the information as it is disclosed may result in the disclosure of another person's information,
 - the information contains an opinion about another person and that person has not consented, and/or
 - The disclosure is prohibited by law.

7. Queries relating to breach of personal information:

Please submit queries relating to the breach of personal information to the JPC's information officer and SCM in writing as soon as the breach is discovered.
