SCOPE OF THE PROCUREMENT:

The services and/or goods required are:

The successful bidder is expected to provide service that manages different types of pests such as:

- Rodents
- Creepy Crawlies
- Flying insects
- Bedbug/Flea
- Termites
- Lice

Pest control and fumigation should be undertaken at all sites with full finding reports that must be forwarded to the respective building manager who will endorse the reports.

All pesticides, insecticides, fumigation and rodent poison to be used must be compliant and approved by the South African Bureau of Standards Code of Practice and Department of Agriculture.

Operational Conditions

- The service provider is expected to apply necessary initial inspection and treatments to bring under control any existing infestations by rodents; creepy crawlies; flying insects; termites; lice; fleas and many others.
- The service provider must conduct monthly inspections of all harborages and likely harborages.
- The service provider must identify pest infestation and specific pest species and treat accordingly.
- The service provider must carry our frequent routine visits to prevent possible pest infestation
- The service provider must place on site a comprehensive pest management file containing all service documents with company details.

1. Crawling Insect and Treatment

- Preventative measures should be taken to prevent insect from nesting. Contact spray, gel or any appropriate treatment may be used provided it is a chemical approved by South African Bureau of Standards. Bait stations should be placed on the interior and exterior and parking lots of buildings. Service and maintenance on these should be performed on a monthly basis or until any infestation has been brought under control as agreed with the respective building manager with warning signs and numbered.

2. Flying Insects Treatment and Control

- Preventative measures should be taken to prevent bees and flies from nesting on the premise





3. Bedbugs ,Fleas, Lice, Termites etc

Preventative measures should be taken to prevent bedbugs and fleas on the premises conduct the identification for all the trouble spots and make proper intervention to resolve. Service reports to be handed to clients on a monthly basis. Identification to be conducted within acceptable environment requirements and controls

4. Operating Hours

Normal operating hours of weekdays (Monday to Friday) 08:00 to 17:00 apply, but if required, after hour's maintenance and serving can be requested. This must be taken into consideration as part of this bid.

5. Relocation of Premises during tenor of contract

If a building lease where the successful bidder is rendering pest control service is terminated. The JPC reserves the right to transfer the same service to new facility. If the lease of a building is terminated and the service cannot be transferred to another facility, the service would be reduced accordingly, and the monthly cost of service will be reduced accordingly.

- 1. All goods or services purchased will be subject to JPC SCM Policy and Procedures. A copy of said conditions is available from the SCMU office.
- 2. All purchases will be made through an official purchase order form. Therefore no goods must be delivered or services rendered before an official purchase order has been forwarded to and accepted by the successful bidder.
- 3. To participate in JPC's Quotation process for the procurement of goods and/or services, vendors are advised to get accredited and registered on Central Supplier Database. The JPC is dealing only with the registered and accredited suppliers on Central Supplier Database.
- 4. All prices quoted must be exclusive of Value Added Tax (VAT). Suppliers / Service Providers who are not registered for VAT will be treated as Non VAT Vendors.
- 5. Prices quoted must include delivery charges and goods must be delivered to the address indicated on the quotation page.
- 6. All prices submitted must be firm. "Firm" prices are deemed to be fixed prices, which are only subject to the following statutory changes, namely VAT and any levy related to customs and excise.
- 7. Quantities are given in good faith and without commitment to JPC. The JPC reserves the right to increase or reduce the quantity to be in line with the set threshold for quotations as prescribed in the SCM Policy.
- 8. Quotation documents must be completed in black ink.
- 9. The lowest price or any quotation will not necessarily be accepted and the JPC reserves the right to accept the whole or any portion of a quotation. The JPC may accept or reject any quotation offer and may cancel the quotation process or reject all quotation offers at any time before the appointment. The JPC shall not accept or incur any liability to the bidder for such cancellation or rejection.
- 10. In the event that the JPC has made an offer to a service provider / supplier and the service provider / supplier declines the offer for whatever reason, the JPC reserves the right to appoint the second acceptable offer and/or re-advertise the requirements.
- 11. The supplier/service provider accepts full responsibility for the proper execution and fulfilment of the goods/services quoted for.

- 13. Quotations are to remain open for acceptance for a period of sixty (60) days effective from the date on which they are closed and shall be accepted at any time within the said period of sixty (60) days.





- 14. In the event of a mistake having been made on the price schedule, it shall be crossed out in ink and be accompanied by an initial at each price alteration. Corrections in terms of price may not be made by means of a correction fluid such as Tipp- Ex or a similar product. If correction fluid has been used on any specific item price, such item will not be considered. No correction fluid may be used in a Bill of Quantities where prices are calculated to arrive at a total amount. If correction fluid has been used, the quotation as a whole will not be considered. The JPC will reject the quotation if corrections are not made in accordance with the above.
- 15. If items are not quoted for, a line must be drawn through the space in pen.
- 16. FORWARD EXCHANGE RATE COVER In the event of price/prices being based on the exchange rate, the successful tenderer/s will be required to obtain exchange rate cover in order to protect the ENTITY against exchange rate variations. Proof must be provided that forward Exchange Rate cover has been taken out within 14 days after an order has been placed. If proof that cover was taken out within 14 days after the order has been placed, is not submitted to The Joburg Property Company, with the invoice, the contract price adjustment will not be accepted and the contract may be cancelled.
- 17. A valid SARS Pin of the Company should be submitted with this quotation document. In cases where the tenderer has not submitted a valid SARS Pin, the JPC reserves the right to at any time after the closure of the RFQ, but before the award of the RFQ, request from the service provider or supplier to provide a valid SARS Pin within two days from date of notification. Bidders should note, that in accordance with legislation, the JPC may not make any award to a person whose tax matters have not been declared by SARS to be in order... - 18. Any quotation will be rejected if the bidder or its director/s are in arrears with their municipal rates and taxes or municipal charges due to any Municipality or any of its entities for more than three months and have not made an arrangement for settlement of same before the request for quotation closure date.
- 19. **Arithmetical errors and discrepancies**

The JPC shall check the highest ranked service provider or supplier with the highest number of points or the successful service provider or supplier after the evaluation of quotations for:

- a. arithmetic errors in:
 - i) calculation of individual rates or price offered in the line items of quantities; or
 - ii) the summation of the prices.

The JPC must correct the arithmetical errors in the following manner: Where there is an error in the calculation of the line items of quantities resulting in the incorrect total amount, the correct total amount after calculation by the JPC shall govern, and the service provider or





supplier will be notified to select within two days from the date of notification whether or not they agree with the corrected total amount.

The JPC will reject the quotation if the service provider or supplier does not correct or accept the correction of the arithmetical error in the manner described above.

The JPC reserves the right to accept or reject the revised quotation based on the corrected amount referred to above.

The JPC will under no circumstances be obliged to notify the service provider or supplier of the arithmetic errors referred to above, and a such the decision to notify and request correction of the errors remains at the sole discretion of the JPC.

CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION **ACT 2013 (POPI)**

This section sets out how personal information will be collected, used and protected by the City of Joburg Property Company SOC Ltd (hereinafter referred to as "JPC"), as required by the Protection of Personal Information Act.
